PENNSWOOD VILLAGE OFFERS ACCOMMODATIONS OF 301 RESIDENTIAL LIVING APARTMENTS OF VARYING SIZES, 37 PERSONAL CARE APARTMENTS WITH 41 LICENSES AND 53 MEDICARE SKILLED NURSING BEDS THAT MEET THE PHYSICAL, SOCIAL, AND SPIRITUAL NEEDS OF RESIDENTS REQUIRING THESE HIGHER LEVELS OF CARE.

THERE ARE NEARLY 16,600 MEALS PREPARED PER YEAR, WHICH EQUATES TO OVER 1,700 STAFF HRS.
